## **VENDOR RULES AND REGULATIONS**

Please read carefully.

**FESTIVAL DATE:** September 23, 2017

**FESTIVAL HOURS:** 9 a.m. to 4 p.m.

**BOOTH FEES:** \$50 (12 X 12 ground or asphalt) **State whether using a tent or trailer and include dimensions. Include a photo of your setup including your product. I understand that if I do not include this information my application will be returned.** I understand the committee will use this information for placement purposes.

**ELECTRICITY FEE:** \$10 (For demonstration purposes only) Not to be used for display, comfort, cooling or campers. Electricity is not available for every booth site.

**DEADLINE FOR APPLICATION:** Booth space can not be guaranteed for **return** vendors after **May 15<sup>th</sup>**. Cut off date for all other vendors is **September 15<sup>th</sup>**. **No exceptions!**

**ARTS AND CRAFTS CATEGORIES:** There is a limit to the number of booth spaces available which is a major reason to return your application as soon as possible. **Exhibits should not contain goods from more than three craft categories listed on the application.** Application must specify in detail all goods to be exhibited for sale. All work must be original, handmade and displayed by the artist/craftsman who sign the application. The festival staff may require removal of work, exhibit or exhibitor in violation of any festival rules.

**PEANUT FESTIVAL JURY:** The uniqueness of your art or craft and the availability of spaces in your craft category will be the main determining factor. Note that the festival jury may not be familiar with your particular craft, and therefore, you should fill out the application completely. Failure to provide photos or slides may impair the judge's decision on your application. All applicants should provide a photo of booth in addition to craft.

**ACCEPTANCE:** Your cancelled check will serve as your notice that application was received. You will be contacted only if your application was not accepted. Specific booth numbers cannot be reserved although we will try to accommodate requests.

**TRAIN SCHEDULE:** The SAM Shortline Train will arrive at 10:45 a.m. with a special run to Archery. The train usually brings approximately 300 people with each trip.

**SET UP/BREAK DOWN:** **If accepted, you must set up PRIOR to 8 a.m. NO EXCEPTIONS!** Breakdown will be **after 4 p.m.** You may set up after 5:00 p.m. on Friday. Please unload vehicle and park in vendor lot, then return to setup your exhibit.

**Note: Streets will be blocked to traffic at 8:00 a.m.**

**ALCOHOL: NO ALCOHOLIC BEVERAGES ARE ALLOWED IN THE SHOW AREA.**

**SALES TAX:** You may be required to collect your own sales tax. Sales tax in Sumter County is eight percent (8%).
