- > I understand and agree that the Plains Peanut Festival, City of Plains, Plains Better Hometown Program or Sumter County are in no way responsible for my goods, my person or my employees during the time I am occupying festival premises.
- > The Plains Peanut Festival will provide no insurance; any insurance must be placed and paid for by the exhibitor. The applicant relieves the management of the show of all responsibility in connection with safekeeping of the property while said properties are at this show.
- ➤ I understand that my vehicle/vehicles should be removed from the arts and crafts area to one of the designated parking areas after unloading. **There is to be NO parking on US Hwy 280**
- ➤ I have enclosed \$50 PER BOOTH exhibition fee as requested on my application. Refunds may be made to those who advise us by September 1st. Size of booth space is 12X12. A PHOTO AND **DETAILED description of tent/trailer size are enclosed**. I have enclosed \$10 extra per day for electricity demonstration as noted on my application. I understand electricity is for demonstration purposes only and that water and ice are not provided.
- > I understand and agree that, if for any reason whatsoever, it becomes impossible to have the festival, this contract is terminated and hereby waives any claim for damages that I may have as a result of said termination. The festival is held rain or shine.

- > I agree to set up my exhibit prior to 8 a.m. Saturday and not to dismantle prior to 4 p.m.
- > I agree to leave exhibit area clean when the festival is over and to practice all safety rules.
- > I agree to bring tables, chairs, cloths, hanging materials and hardware for my booth. Freestanding tents are permitted but **NO funeral tents allowed**. No tables or other supplies will be furnished.
- > I understand that NO ALCOHOLIC BEVERAGES are allowed in the festival area and that food must be sold by authorized food vendors only.
- > I understand that I am required to collect seven percent (8) sales tax. Sales tax forms will be distributed at the festival.
